

## **JOHNSTOWN PERMIT FEES**

### **Residential**

12-2019

- 1) **VALUATION** - The total valuation of all construction work including but not limited to: architectural, structural, electrical, plumbing, and mechanical, including contractor's markup/profit, labor, excavation, foundation, framing, air conditioning, finish work, painting, roofing, fire extinguishing systems, water and sewer taps, and any other permanent equipment.
- 2) **BUILDING PERMIT FEE** - Based on the valuation. Refer to Residential Appendix **A**
- 3) **PLAN REVIEW FEE** - Residential plan review fee is 30% of building permit fee.  
**A plan review submittal fee is required when applying for a building permit.**  
Refer to Residential Appendix **B**
- 4) **ELECTRICAL PERMIT FEE** - Refer to Residential Appendix **C**
- 5) **PAVING/STREET IMPROVEMENT FEE** - Refer to Residential Appendix **D**
- 6) **WATER UPGRADE FEE** - Refer to Residential Appendix **E**
- 7) **WATER & SEWER REIMBURSEMENT FEE** - Required in the following subdivision:
  - a) Corbett Glen \$1,631.00
- 8) **WATER TAP FEE** Refer to Residential Appendix **F**
- 9) **SEWER TAP FEE** Refer to Residential Appendix **F**
- 10) **SEWER PERMIT & INSPECTION FEE** \$100.00
- 11) **PARK FEE** \$500.00 for each new residential house building permit.
- 12) **USE TAX**
  - a) Town of Johnstown Use Tax - 3% of retail materials.
  - b) Larimer County Use Tax - .08% of retail materials.
- 13) **DEVELOPMENT FEE - SINGLE FAMILY DETACHED** Refer to Residential Appendix **G**
- 14) **DEVELOPMENT FEE - OTHER DWELLING UNITS** Refer to Residential Appendix **H**

Greater than 2001 sq. feet (\$155 + (\$6 x each additional 100 sq. feet)	
<b>Example:</b> (2235 sq. ft) first 2000 sq. ft. = \$155 + (300 (235 rounded up to next 100) x \$6) = \$173	

<b>Solar Installation</b>	
<b>Valuation of Installation – (Based on cost to customer of labor, material &amp; items)</b>	
	<b>Fee</b>
Not more than \$2000 (Base fee)	\$77
\$2001 and above = \$77 + \$6.00 per thousand <b>of total job valuation</b> always round up the next \$1000 of valuation	
<b>EXAMPLE:</b> The valuation is \$5,150 (round up to \$6,000) The base fee as shown above; \$77 + (6x\$6.00) = \$113.00 total fee
